- **Changes to Booking:** Any changes to your booking (e.g., date, time, inventory) must be requested as soon as possible by contacting Motion Lane Movers, LLC directly. Changes are subject to availability and may incur additional charges.

Any legal action or proceeding arising out of or related to these Terms shall be brought exclusively in the state or federal courts located in Orange County, Florida.
